

REGULATION

This regulation has the objective of setting some useful rules valid for any excursion proposed.

At first sight, setting rules could be seen as an attempt to set impositions and must dos, but we want you to consider that there are many complicated factors that could influence the good outcome of an excursion. The mountain environment could be unpredictable and sometimes dangerous, we will be in groups made by a wide variety of people: not everybody is in the same physical health, everybody has its own ideas, habits and personality. This is to be considered as an added value of course, but we invite you to read carefully the following regulation before deciding to take part in our activities.

PARTICIPANTS

1. Everybody can join our activities and trips and it is mandatory to register before taking part.
2. Minors must be accompanied by an adult (parents or a guardian), who is regularly registered to the excursion.
3. The guide, who is directly liable for the excursion, can decide, due to technical evaluations, to limit the number of people who can join the trip.
4. Participants must be in good physical conditions and must inform the Organization at the moment of the registration about possible health problems.
5. Participants must have read carefully this regulation published on the website www.Orobie4Trekking.com before the registration.
6. At the moment of the registration participants accept all the rules published in this regulation.

OBLIGATIONS OF THE PARTICIPANTS:

1. Before taking part to the trip:
 - a. Participants must be informed about technical difficulties. And self- evaluate its physical and health conditions and the equipment needed and recommended by the guide before the registration.
 - b. Participants must show respect towards other participants and the environment (no matter if it will be part of a protected area or not). In particular: it is forbidden to leave trash, it is forbidden to pick up flowers or mushrooms from the soil, it is forbidden to disturb the fauna.
2. During the excursion participants must:
 - a. Carefully listen and follow the rules and advice given by the guide.
 - b. Be equipped with the equipment suggested by the guide.
 - c. Stay in the group without going on dangerous or not predicted paths and to follow the guide in order to avoid dangerous situations.
 - d. Inform the guide before leaving or stepping away from the group.
 - e. Follow the Orobie4Trekking regulation.
 - f. Behave respectfully and politely.
 - g. Collaborate with the guide and with the other members of the group in order to ensure everyone's safety and the good outcome of the trip.
 - h. Be very careful in particular on exposed paths in order to ensure the safety.

- i. In case of an accident, follow carefully the instructions of the guide who is expert and prepared to face emergency situations.
3. The registered participants must communicate with the guide or the agency in case of no show.

ORGANISATION OF THE DAY

1. During the trips all the lunches are usually consumed in nature or around the city and are usually take away lunches not provided by Orobie4Trekking.
2. Participants must come at the meeting point equipped with everything they will need for the trip.
3. At the meeting point the guide will check-in all the participants and make sure they are regularly equipped.
4. The trip starts once the participants have checked-in with the guide.
5. The trip ends once the participants will have check-out.
6. The guide can decide to change the itinerary due to unpredictable events.
7. The guide can decide to cancel the trip whether the conditions are not optimal for the participants' safety. This will be communicated as soon as possible to the participants.

INDEMNITY OF THE PARTICIPANT:

The guide has the right to decide the removal of the participants from the trip in the following cases:

1. The participant is not fully and regularly equipped.
2. The participant show bad physical or mental condition.
3. The participant does not follow the guide's instructions.
4. The participant put at risk the group's safety with dangerous actions.
5. The participant decide to leave the group, in front of witnesses to follow another path different from the one that had been agreed.
6. The participant do not comply with the rules of this regulation

The removal of the participant from the trip means the exclusion of liability of the guide. In case of a minor, the guardian will be excluded as well from the trip.

The participant who willingly decides to step away from the trip and continue or not the trip alone, will not have the right to any refund.
